June and July-Gene K

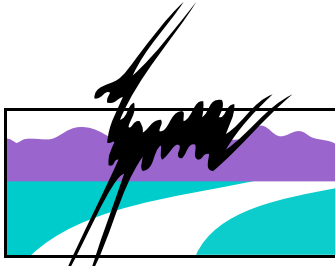
### 3. Club Activities:
